Hello and welcome to the beginning of summer as the fate of the USPS hangs in the balance. Is this the end of the postal service as we know it today? Here in Green Bay, we had auditors come in and found delay mail from 2 weeks ago. We had management hiding mail on trucks only to have that mail come back the next day when auditors aren't looking. We had 1 day where no DPS mail went out and rural carriers got paid double to handle two DPS routes. The plant is not allowing overtime, but carriers are getting it all, working late because their mail is late. We still have management continuing to do clerk work when there is NO EMERGENCY. This year's voting ballots will be delayed by the USPS and when that happens all trust is finally gone. PMG Dejoy is getting raked by Congress on his 10- year failing plan but cannot be removed at this time.

I attended the town hall meeting in Iron Mountain-Kingsford area processing plant, and they are changing the name to SDC or service distribution center. The big wigs told the people that outgoing mail will go to Green Bay and be processed that day. I heard the speakers, then the public got to respond about the terrible service and only one day mail pickup. Iron Mountain is a 2-day service, but this 2-day service starts when Iron Mountain receives the mail pieces. So, if you live in Marquette, Michigan, and mail something on

Thursday and it arrives in Iron
Mountain on Friday then they get 2 days to process the mail, Friday and Saturday, but we don't deliver on



Sunday so maybe Monday delivery? Then I listened to a water testing company representative that stated they cannot properly test water samples because it must be a 24 hour turn around and the snail mail is too slow. I then got a chance to speak and ask the speakers what machines will still be in Iron Mountain when all the changes are done and what crafts will be impacted when the move happens, and I received no response. I then went on to say that Monday thru Friday we will process the letters we receive that night on AFCS's, but not on Saturday, Sunday, and the holidays – that mail will go to Milwaukee. The packages will not be processed in Green Bay, but rather Oshkosh for now. I was told no that is not true. Tell me folks where is the package sorting machine in Green Bay? On a positive note, weather is getting warmer, go get outside, get some exercise, and go plant something, later my union brothers and sisters.

For Sam, Jenny, and Sebastian this was the first time attending a convention as delegates weighing in on the resolutions, we would like to see in the upcoming contract negotiations. If accepted, these potential contract changes could be brought up again at the National convention, possibly accepted and fought for in the upcoming contract negotiations. While voting we were able to hear all issues that other offices in Wisconsin were having trouble with, and President Heaney addressed the delegate on issues that our Local has been handling, such as retaliation and harassment by management on employees.

Jerry Labinski was nominated and re-elected as the Director of Human Relations, including the Education and Organization of the APWU of Wisconsin. Lastly, Steve Lord was nominated and re-elected as the Legislative Director of the APWU of Wisconsin.

Beyond voting for resolutions, we attended a general grievance writing class. During which our National Business agents stressed the importance of investigations and documentation. This helps tremendously by writing statements, getting down what happened, who was involved, and when did it happen... It all helps during the grievance procedure and investigation.

Sam and Jenny also attended a breakout class for maintenance. During the maintenance portion of the convention, we were informed that the AMT (Area Maintenance Technician) position's job tasks are being completed by other maintenance personal and management around the country. In other smaller post offices, management is trying to eliminate BEMs (Building Maintenance Mechanic) and forcing AMTs from other facilities to complete the once BEM work. We now have the knowledge of how to fight to get more AMT positions. If you or any coworkers are given the task of changing locks, checking fire extinguishers, checking, or changing lightbulbs on exit signs, or any other tasks outside of your job description, please let a steward know so we can take care of this ASAP.

Throughout the week we all had a great time meeting a lot of great people. We talked about issues our offices are having and learned new ways to handle them. We also met a lot of new stewards from our state and it's exciting to imagine standing with them for years to come!

Labor/Management: Items discussed were lack of mail handler coverage on the culling belt when the AFCS is run on tour 3, supervisor harassing clerks and addressing employees in a way that makes them feel uncomfortable or threatened, with no call no shows what determines whether they call the employee or not, machine partners and singling out only certain employees; several employees have been paired up on the same machines for months with the same partner while others are split up, overcrowded parking lot, new updated seniority list, custodian hazmat training is not complete, evacuation maps are in need of updates, emergency contact lists for plant needs updating, AED by front office needs updating sign telling where the other AED is located, Narcan no longer available, first responder training class, pit operators going around corners and almost hitting employees several times, APCs continue to be stored in the aisle by manual letters, lack of fire and tornado drills.

# **TONY VAN SCHOLARSHIP**

# There shall be two (2) scholarships of \$500.00 each.

- 1. The funds for these scholarships are to be raised by the NEWAL local and approved at a regular membership meeting.
- This scholarship is for graduating high school seniors and students currently attending a school listed in #3 up to the age of twenty-six (26).
- The student must prove their acceptance to an accredited University, College, Trade, Technical and/or Vocational School not later than September 30, 2024.
- The student must have maintained a "C" or 2.0 grade point average over their high school/college curriculum.
- Verification of grades and graduation must be supplied before payments are made.
- 6. At least one parent, legal guardian, or grandparent <u>must be a member of the APWU NEWAL</u>, in good standing, for a minimum of 1 year following, except in the case of death of a member.
- 7. The Scholarship Committee shall consist of up to five (5) members. Two (2) of these members shall consist of the current elected President and Secretary/Treasurer of the APWU NEWAL. The President of the APWU NEWAL shall appoint the remaining members.
- The Committee shall be convened by July 13, 2024 or the Monday thereafter. The Committee Chairman will have verified each of the membership qualifications by this date.
- 9. The submission deadline (by mail only) for scholarship applications is <u>Friday</u>, <u>July 12</u>, <u>2024</u>. The drawing shall be held at the summer picnic on <u>August 4th</u>. If there is no picnic, the winners will be drawn at the September union meeting.
- 10. The Committee, upon verification of each application, shall place said applications in plain "gold" envelopes. There shall be two (2) winners and one alternate drawn.
- 11. The scholarships will be paid to the school scholarship offices. The scholarship must be used within the following scholastic year.
- 12. The selected student(s) shall submit to the Committee Chairman, proof of his/her full-time enrollment (Current Enrollment Verification Certificate) from the school of their choice as set forth in rule number four (3). Payment shall be made upon the receipt of verifications.
- 13. All disputes concerning the Scholarship Program shall be submitted to the Committee Chairman within thirty (30) days of the drawing, in written form. They shall be answered in writing within fifteen (15) days.
- 14. These rules governing the TONY VAN SCHOLARSHIP FUND, sponsored by the APWU NEWAL can only be amended, changed, or deleted once a year at the summer meeting of the Scholarship Committee. Only one <u>mailed</u> application per student will be allowed.


