### **TONY VAN SCHOLARSHIP**

There shall be two (2) scholarships of \$500.00 each.

1. The funds for these scholarships are to be raised by the NEWAL local and approved at a regular membership meeting.

- 2. This scholarship is for graduating high school seniors and students currently attending a school listed in #3 up to the age of twenty-six (26).
- 3. The student must prove their acceptance to an accredited University, College, Trade, Technical and/or Vocational School not later than September 30, 2025.
- 4. The high school student must have maintained a "C" or 2.0 grade point average over their high school curriculum.
- 5. Verification of grades and graduation must be supplied before payments are made.
- 6. At least one parent, legal guardian, or grandparent must be a member of the APWU NEWAL, in good standing, for a minimum of 1 year following, except in the case of death of a member.
- 7. The Scholarship Committee shall consist of up to five (5) members. Two (2) of these members shall consist of the current elected President and Secretary/Treasurer of the APWU NEWAL. The President of the APWU NEWAL shall appoint the remaining members.
- 8. The Committee shall be convened by July 25, 2025, or the Monday thereafter. The Committee Chairman will have verified each of the membership qualifications by this date.
- 9. The submission deadline (by mail only) for scholarship applications is July 20, 2025. The drawing shall be held at the summer picnic in August. If there is no picnic, the winners will be drawn at the September union meeting.
- 10. The Committee, upon verification of each application, shall place said applications in plain "gold" envelopes. There shall be two (2) winners and one alternate drawn.
- 11. The scholarships will be paid to the school scholarship offices. The scholarship must be used within the following scholastic year.
- 12. The selected student(s) shall submit to the Committee Chairman, proof of his/her full-time enrollment (Current Enrollment Verification Certificate) from the school of their choice as set forth in rule number four (3). Payment shall be made upon the receipt of verifications.
- 13. All disputes concerning the Scholarship Program shall be submitted to the Committee Chairman within thirty (30) days of the drawing, in written form. They shall be answered in writing within fifteen (15) days.
- 14. (ESSAY) A 200-word (maximum) essay required on the topic: "The Importance of Unions to American Society" Essays will not be judged, but the winning applicants will have theirs published in the next Bay Breeze.
- 15. These rules governing the TONY VAN SCHOLARSHIP FUND, sponsored by the APWU NEWAL can only be amended, changed, or deleted once a year at the summer meeting of the Scholarship Committee. Only one mailed application & essay per student will be allowed.

## MINUTES OF MONTHLY MEETING OF NORTHEASTERN WISCONSIN AREA LOCAL #2247

Date: Thursday, May 15th, 2025

Place: Kroll's West

President Jenny Ewald called the meeting to order at

7:35pm.

A quorum was declared with 18 members in attendance.

Jenny Ewald led the Pledge of Allegiance and Steve Paradise gave the Invocation.

The following officers were present: President Jennifer Ewald, Vice President David Sass, Secretary/Treasurer Molly Crevier, Clerk Craft Director Sebastian Zeutzius, Motor Vehicle Craft Director Clade Adkins, Recording Secretary Emily Ewald, and Bay Breeze Editor Bill Kabacinski. Maintenance Craft Director Samantha Fritz was excused.

Minutes of the April 2025 meeting were printed in the Bay Breeze. A motion was made by Steve Paradise and seconded by Clade Adkins to accept the minutes. Motion passed.

The official financial report was read by Secretary/ Treasurer Molly Crevier.

Executive Committee: The e-board unanimously voted to allow Jacqueline Walitalo to enter the E-board meeting to allow her to see what happens and what is discussed. The E-board discussed the budget for this year and if we can order more T-shirts, they decided to spend up to \$3,000 ordering new shirts for members. BMU and VMF not taking lunches, and the grievance for maintenance to take lunches was settled, clerk craft grievance for lunches is being sent to step 2. Supervisors are trying to make changes in the absentee policy, that they are trying to make every day as an occurrence instead of 3 consecutive days is one. Discussed if the secretary/treasurer should get a pay increase due to the amount of work and time that is involved. Discussed the different conferences coming up and who is attending, and a workstation or computer is needed for stewards at Cofrin and downtown.

Labor/Management: Items discussed were what other programs are going to be taken out of the plant, now we are slotted to keep the cancelers and no plan yet to get rid of the flat sorter. No excessing for the plant, and no plan to get rid of any automation machinery. Canceler run/start times are starting earlier but not till August because of changes in transportation. More shifts in the plant might be moved to tour 2. Express/registry bags are being

sent to Milwaukee. Coffrin is losing their 2-day window, semi-truck drivers are driving too fast around the VMF. 11 jobs are coming down off e-reassign, should have 9 PSE conversions. Supervisors in the plant harassing employees on the floor. Drop shipments were not allowed on the dock from 2pm-4pm.

Safety/Health: Items discussed were the plant parking lot is in the process of being approved to be fixed, maintenance will order patch mix to fill in holes. The fire alarm system went off but not in the building, it was checked and is back on and operational. The emergency door by the employee entrance was going off for more than 30 minutes without a supervisor being notified. The growing pile of clutter under the mezzanine behind flat sorter 20 is becoming a safety concern. Employees leaving the back door open on the dock, supervisors will give a service talk. The PA system in the back is not working; a ticket was put in to get it fixed. Holes in the floor downtown, clerks pulling empty equipment, fire extinguishers being blocked by equipment, and AC units in the plant are not working.

Grievance: Step 2 for clerk craft on no lunches, maintenance grievance settled, discipline cases, Cofrin conversion, overtime bypass, small offices the PTF's working ihr then forced to take a lunch, window clerks that are on the overtime desired list are not allowed to come in early or work off day, tax grievances.

Legislative: Steve Paradise informed members that congress is discussing the retirement of Federal employees, including postal workers. They are trying to cut back on the money you get for retirement; they want to extend to a 5 year instead of a 3 year plan

New Members: Bryant Fowle and Jennifer Brandt

Lost Members: Gary Savona

Communications: The auxiliary has been paid; the Greater Green Bay Labor temple has not reached out after being paid to re-enter.

#### **NEW BUSINESS**

A motion was made by Molly Crevier and seconded by Clade Adkins to spend up to \$3,000 on a new order of union t-shirts.

Discussion was held on a pay increase for the secretary/ treasurer.
